SCRUTINIZER'S REPORT

Scrutinizers Report on postal ballot voting including voting by electronic means in respect of passing of the resolutions contained in the Notice dated 3rd October, 2015 through Postal Ballot.

Dear Sir,

In terms of provisions of Section 110 of the Companies Act, 2013 read with Companies (Management and Administration) Rules. 2014, I, K. Jhansi Laxmi, Company Secretary, was appointed as the Scrutinizer by Krebs Biochemicals and Industries Limited ("the Company") vide resolution passed by its Board of Directors at its meeting held on 3rd October, 2015, for conducting the Postal Ballot and e-Voting process and furnish my report for obtaining the approval of members for the Special Resolutions set out in the Notice of Postal Ballot dated 3rd October, 2015.

I submit my report as under:

- On the basis of the Register of Members and the List of Beneficiary owners made available by the Depositories viz.. National Securities Depository Limited (NSDL) and Central Depository Services (India) Limited (CDSL) as on 2nd October, 2015, the Company completed dispatch of the Notice of Postal Ballot on 7th October, 2015;
 - by email to 2581 members who had registered their email ids with the Company or as provided by the Depositories or the Registrar and Share Transfer Agents and
 - by Registered Post/Courier to 3475 members in Physical Form.
- The e-voting commenced from 9th October, 2015 (9.00 AM) and ended on 7th November, 2015 at 5.00 PM.
- 3. The Company has also published an advertisement in one English Newspaper i.e., "Financial Express" and in one Regional Newspaper i.e., "Prajashakti, Hyderabad Edition." On 9th October, 2015 about the dispatch of the Notice and Postal Ballot Forms as required under the provisions of Section 110 of the Companies Act, 2013 read with Rule 22 of the Companies (Management and Administration) Rules, 2014.

- 4. In terms of the aforesaid notice, members were required to convey their assent / dissent, as the case may be on or before 7th November, 2015 in respect of the Special Resolutions as set out in the Notice of Postal Ballot dated 3rd October, 2015:
 - In case of Postal Ballot Forms mailed to them by the Company in prepaid envelopes addressed to me, on or before 7th November, 2015
 - In case of e-Voting, votes to be cast electronically on e-Voting platform provided by Karvy Computershare Private Limited on or before 7th November, 2015 before 5.00 p. m.
- 5. I received 10 Postal Ballot forms and 8 members casted their vote on the e-Voting Platform, till 5.00 p.m. on 7th November, 2015, being the last date for receipt of duly completed postal ballots forms and e-Voting on Karvy portal, as per the said notice.
- 6. With the support of Karvy Computershare Private Limited, the Registrar and Share Transfer Agents of the Company, the Postal Ballot Forms were scrutinized and signatures of members who had cast their votes were verified with their specimen signatures registered with the Company and as provided by the Depositories.
- 7. In case of e-Voting, Members' demographic details, their voting rights and voting pattern were provided by Karvy Computershare Private Limited.
- I have downloaded the e-Voting Report from the website https://evoting.karvy.com of Karvy Computershare Private Limited, the Authorised Agency to provide e-voting facility, by using the Scrutinizer's Login ID and Password at 9.40 p.m., on 8th November, 2015.
- 9. All the ballot forms received / votes casted in e-Voting website of Karvy upto the close of working hours i.e., 5.00 p.m. on 7th November, 2015 being the last date and time fixed by the Company for receipt of the forms were considered for scrutiny.
- 10. No Envelopes containing the Postal Ballot Forms were received after 5.00 p. m., on 7th November, 2015.
- 11. There are no defaced / mutilated ballot papers.
- 12. After the aforesaid scrutiny of the Postal Ballot Forms and taking into account the e-Voting results, I report that the Special Resolutions as contained in the said Notice has been passed with requisite majority.

I have annexed with this Report, the details of the Postal Ballot and e-Voting and the analysis of the Results of the Special Resolutions as contained in the said Notice.
